- The 2015 revised Worker Protection Standard (WPS),
- The 2017 revised Certification of Pesticide Applicators Rule, and/or
- Other pesticide-related topics

Projects may include brochures, fact sheets, posters, videos, manuals, exams, mobile apps/tools, web content, and/or other items. These materials need to educate people and potentially prevent pesticide exposure incidents that may affect the environment, the public, pesticide applicators and/or their families.
